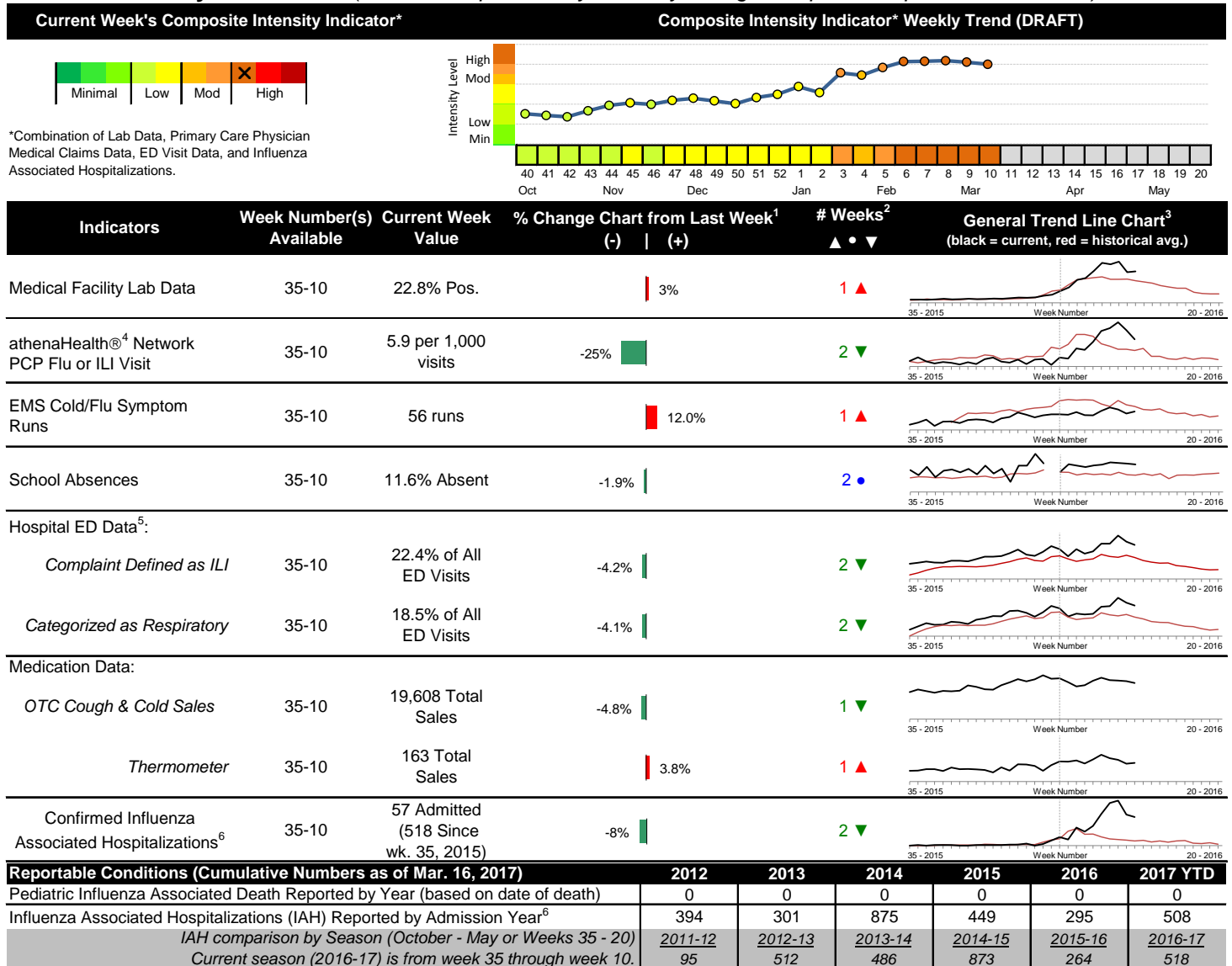


2016-2017 Columbus & Franklin County Seasonal Influenza Activity Weekly Summary (Week 10, Mar. 5th, 2017– Mar. 11th, 2017)

Highlights

- In week 10 of 2017, the individual local flu activity indicator trends were mixed compared to last week, with the majority above their baseline averages. As a whole, flu intensity (composite indicator) decreased slightly but continued to be high.
- Geographic spread and local intensity designation (Click [here](#) for definitions) = WIDESPREAD, HIGH
- Local medical facility labs reported 2,521 tests run with 575 (22.8%) positive results for week 10 of 2017. This is close to last week's 22.6% and is higher than the weekly baseline.
- The percentage of ED visits for both influenza-like-illness (ILI) and respiratory symptoms decreased slightly compared to last week. The percentage of ED visits for both ILI and respiratory symptoms are above their respective baseline averages for the week.
- In week 10 of 2017, the trends for categories of local over-the-counter medication sales tracked were mixed (increase in thermometer sales; decrease in cough and cold, chest rub, adult anti-fever, and throat lozenge sales; stable electrolyte and pediatric anti-fever sales) compared to last week.
- Nationally, influenza activity decreased, but remained elevated in the United States. Please [visit the CDC website for specific information](#) (National data is usually updated on Friday of each week).

Influenza Morbidity and Influenza-Like Illness (ILI) Reports

In week 10, the preliminary local influenza and influenza-like-illness (ILI) visit rate to athenaHealth® providers (5.9 per 1,000 visits) decreased compared to the previous week and is above its baseline average for the week (Figure 1). The week 10 percentage of all Emergency Department (ED) visits categorized as ILI decreased slightly compared to the previous week (Figure 3) and is above its historic baseline for the week.

Nationally, during week 10 of 2016, 3.7% of patient visits reported through ILINet were due to influenza-like illness (ILI). The percentage is above the national baseline of 2.2% for week 10.

Laboratory Surveillance

During week 10 of 2017, reporting Franklin County sentinel medical facility laboratories tested 2,521 specimens, with 575 (22.8%) positive (Figure 4). The total number of tests done by local reporting labs from week 35 of 2016 through week 10 of 2017 is 37,193 with 5,569 (15.0%) positives (4,261 type A, 1,303 type B, 5 type A and B, 0 type unknown).

Nationally in week 10 of 2017, clinical laboratories reported 27,105 specimens tested for influenza viruses, 4,967 (18.3%) of which were positive (3,037 type A, 1,930 type B). Public health laboratories reported testing 1,511 specimens, 727 of which were positive (514 type A – of which 16 were A(H1N1)pdm09, 476 were A/H3, and 22 were not subtyped; 213 type B – of which 126 were Yamagata lineage, 34 were Victoria lineage, and 53 where lineage was not performed). In week 10 of 2017, participating Ohio clinical labs reported 42,208 specimens tested for influenza this season thus far. Positive results include: (5) A(H1N1)pdm09; (495) A/H3N2; (3,226) Flu A Not Subtyped, and (1,831) Flu B (through 3/11/17). ODH Public Health Lab reported 996 specimens tested for influenza from various submitters this season thus far. Positive results include: (4) A(H1N1)pdm09; (638) A/H3N2; (159) Influenza B (through 3/11/17). Please visit the ODH website for more information.

ED Respiratory Visits

In the 10th week of 2017, the percentage of all ED visits categorized as respiratory decreased compared to the percentage seen the previous week and is above its historic baseline for the week (Figure 5).

Over-the-Counter (OTC) Medication Sales

In week 10 of 2017, the trends for categories of local over-the-counter medication sales tracked were mixed (increase in thermometer sales; decrease in cough and cold, chest rub, adult anti-fever, and throat lozenge sales; stable electrolyte and pediatric anti-fever sales) compared to last week.

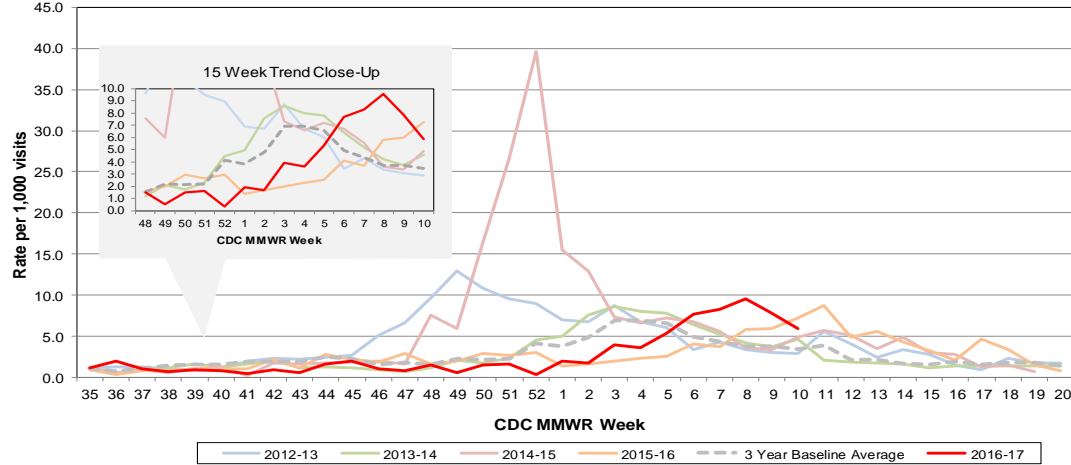

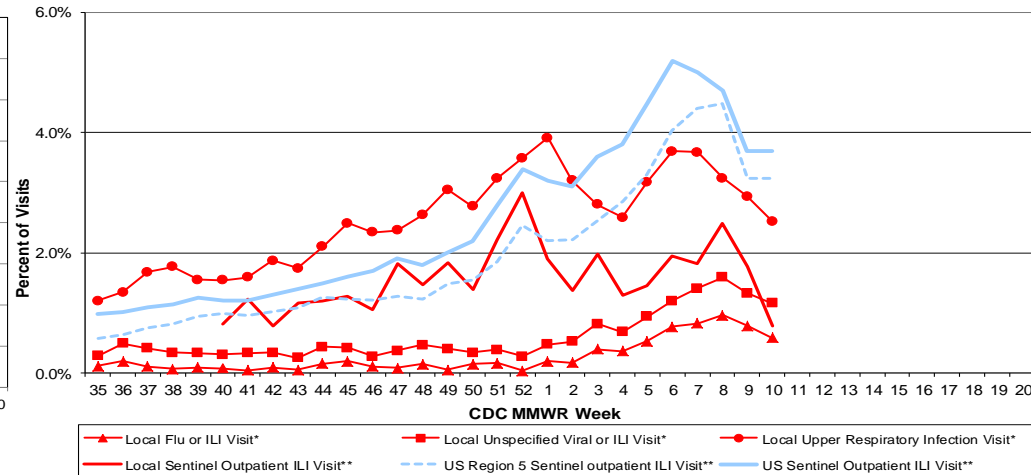

Figure 1: Local Participating Outpatient Primary Care Provider Influenza or Influenza-Like Illness Visit Rate[†], Franklin County, OH



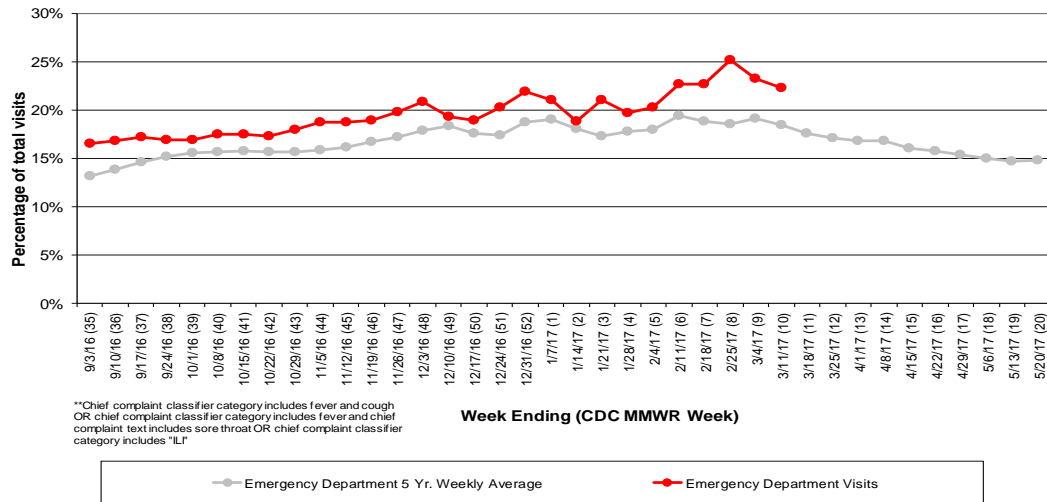

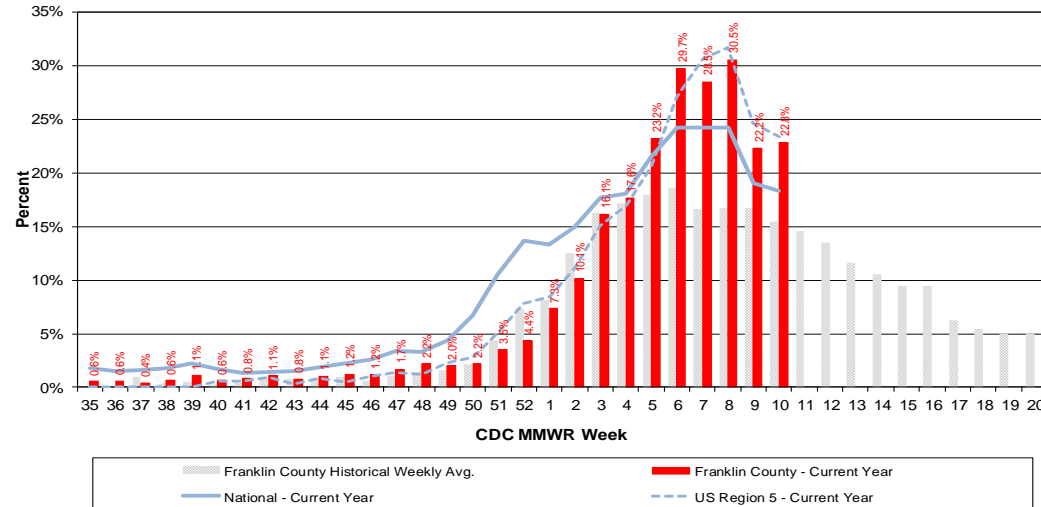

Figure 5: Franklin County Resident Respiratory ED Visits, 2016-17, Franklin County, OH

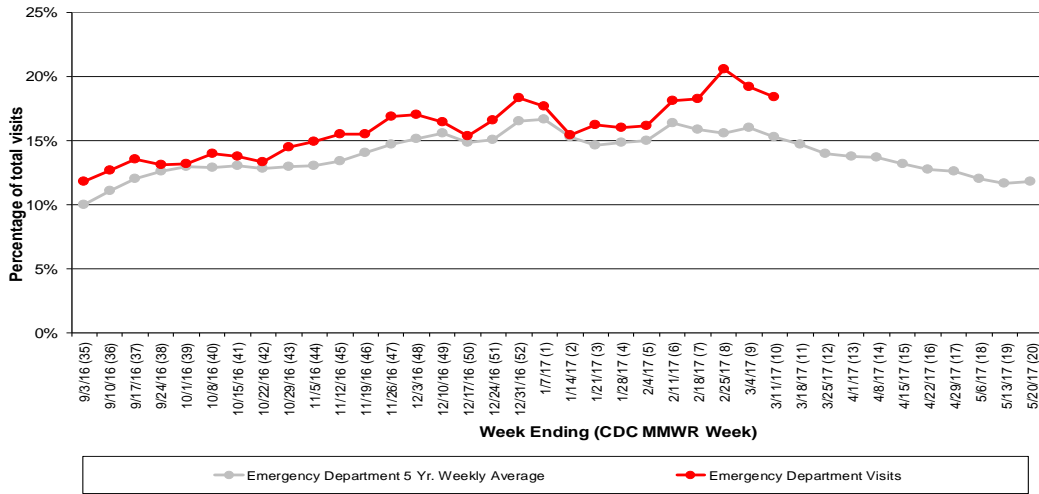


Figure 6: Selected Number of Over-the-Counter Medication Sales, 2016-17, Franklin County, OH

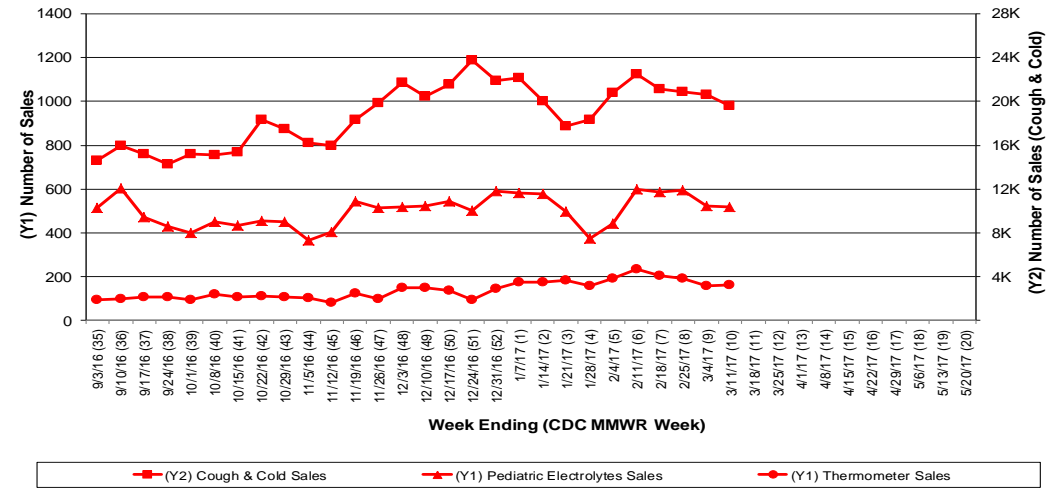
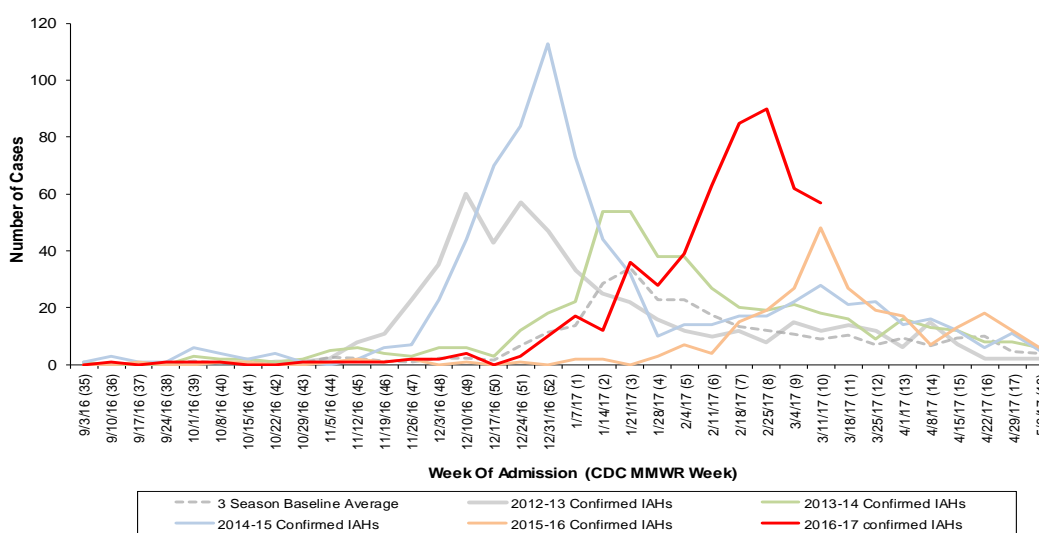


Figure 7: Franklin County Confirmed Influenza Associated Hospitalizations by Hospital Admission Week (As of 3/16/2017)
