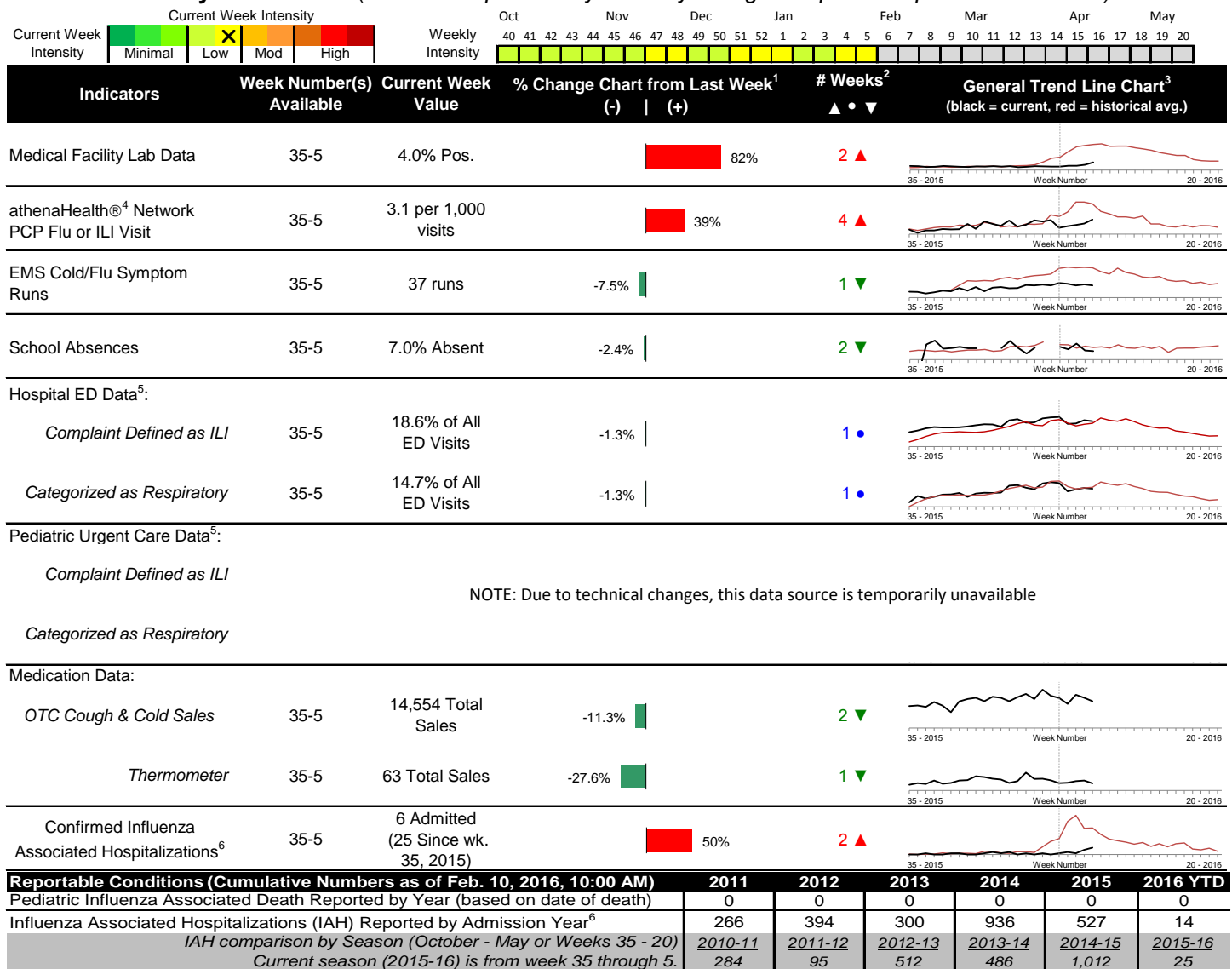


### Highlights

- In week 5 of 2016, the individual local flu activity indicator trends were mixed. Overall, local flu intensity continues to be low, but increased compared to the previous week. Notable increases in lab positives, outpatient visits, and hospitalizations were seen.
- Geographic spread and local intensity designation (Click [here](#) for definitions) = LOCALIZED, LOW
- Local medical facility labs reported 990 tests run with 40 (4.0%) positive results for week 5 of 2016. This is higher than last week's 2.2% and is lower than the weekly baseline.
- The percentage of both ED visits for influenza-like-illness (ILI) and respiratory symptoms were stable compared to week 4. Both the percentage of ED visits for ILI and Respiratory symptoms approached their baseline averages for the week.
- In week 5 of 2016, trends for all of the local over-the-counter medication sales tracked decreased (decrease in cough and cold, electrolyte, thermometer, chest rub, pediatric anti-fever, adult anti-fever, and throat lozenge sales) compared to last week.
- Nationally in week 5, influenza activity increased slightly in the United States. Please [visit the CDC website for specific information](#) (National data is usually updated on Friday of each week).

### **CDC 122-Cities Mortality Reporting System: Pneumonia and Influenza (P&I) Mortality**

In week 5 of 2016, 6.0% of all Columbus and Franklin County deaths were attributed to pneumonia and influenza. Nationally in week 5, 6.2% of deaths reported were attributed to pneumonia and influenza. This national percentage was below the national epidemic threshold for week 5.

### **Influenza Morbidity and Influenza-Like Illness (ILI) Reports**

In week 5, the preliminary local influenza and influenza-like-illness (ILI) visit rate to athenaHealth® providers (3.1 per 1,000 visits) increased compared to the previous week and is below its baseline average for the week (Figure 1). The week 5 percentage of all Emergency Department (ED) visits categorized as ILI was stable compared to the previous week (Figure 3) and is close to its historic baseline for the week.

Nationally, during week 5 of 2016, 2.4% of patient visits reported through ILINet were due to influenza-like illness (ILI). The percentage is above the national baseline of 2.1% for week 5.

### **Laboratory Surveillance**

During week 5 of 2016, reporting Franklin County sentinel medical facility laboratories tested 990 specimens, with 40 (4.0%) positive (Figure 4). The total number of tests done by local reporting labs from week 35 of 2014 through week 5 of 2016 is 18,447 with 201 (1.1%) positives (153 type A, 44 type B, 4 both A and B, 0 type unknown).

Nationally in week 5 of 2016, clinical laboratories reported 17,175 specimens tested for influenza viruses, 1,563 (9.1%) of which were positive (1,135 type A, 428 type B). Public health laboratories reported testing 1,233 specimens, 443 of which were positive (325 type A – of which 255 were A(H1N1)pdm09, 42 were A/H3, and 28 were not subtyped; 118 type B – of which 44 were Yamagata lineage, 18 were Victoria lineage, and 56 where lineage was not performed). In week 5 of 2016, participating Ohio clinical labs reported 13,865 specimens tested for influenza this season thus far. Positive results include: (11) A(H1N1)pdm09; (3) A/H3N2; (64) Flu A Not Subtyped, and (20) Flu B (through 2/6/16). ODH Public Health Lab reported 108 specimens tested for influenza from various submitters this season thus far. Positive results include: (10) A(H1N1)pdm09; (1) A/H3N2; (1) Influenza B (through 2/6/16). Please visit the ODH website for more information.

### **ED Respiratory Visits**

In the 5<sup>th</sup> week of 2016, the percentage of all ED visits categorized as respiratory was stable compared to the percentage seen the previous week and is close to its historic baseline for the week (Figure 5).

### **Over-the-Counter (OTC) Medication Sales**

In week 5 of 2016, trends for all of the local over-the-counter medication sales tracked decreased (decrease in cough and cold, electrolyte, thermometer, chest rub, pediatric anti-fever, adult anti-fever, and throat lozenge sales) compared to last week.

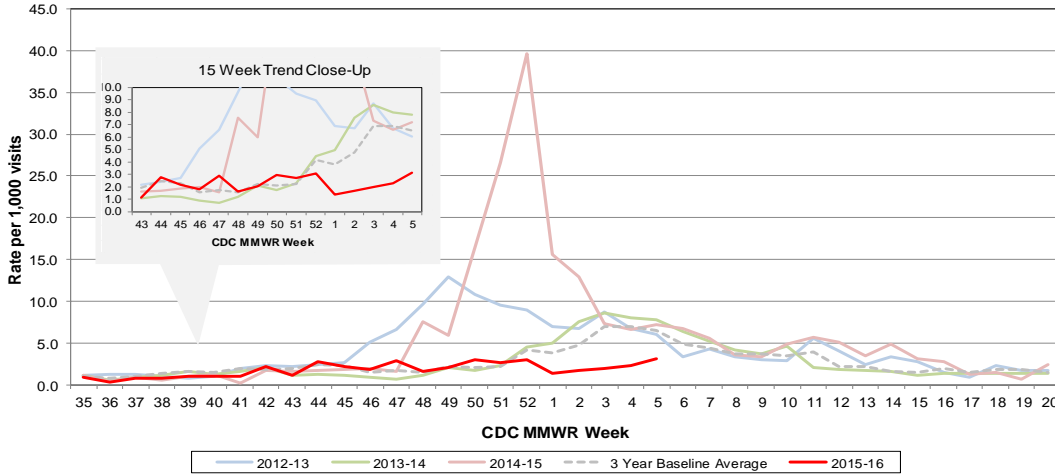

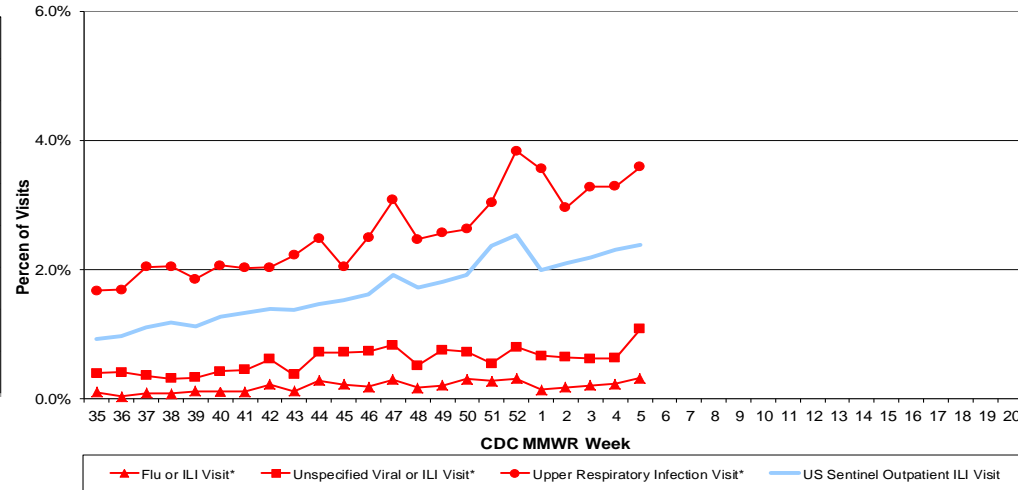

**Figure 1: Local Participating Outpatient Primary Care Provider Influenza or Influenza-Like Illness Visit Rate\*, Franklin County, OH**



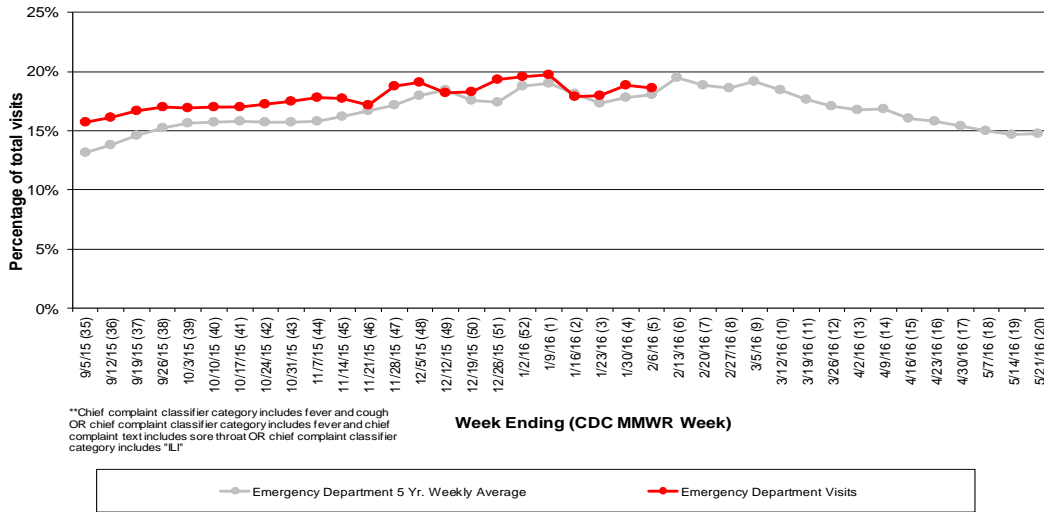

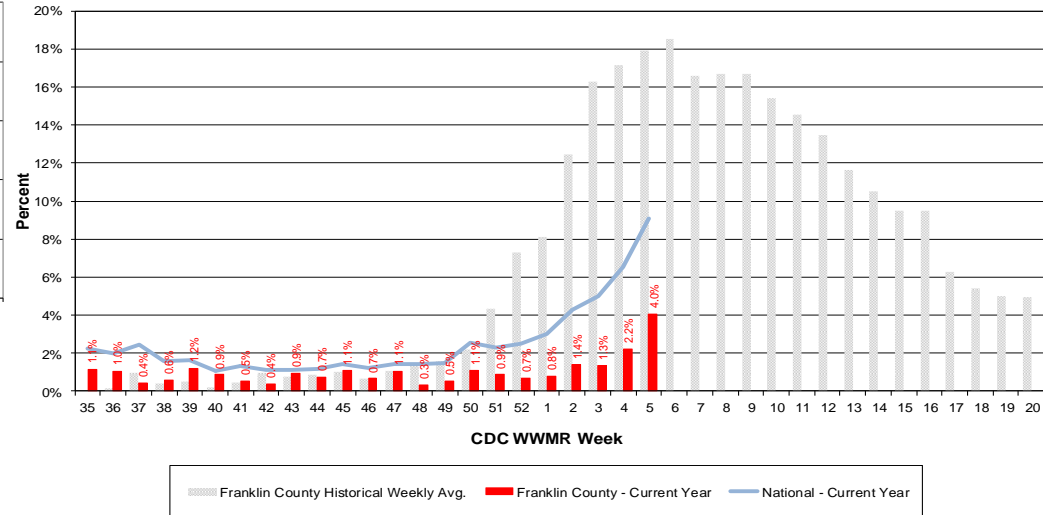

Figure 5: Franklin County Resident Respiratory ED Visits, 2015-16, Franklin County, OH

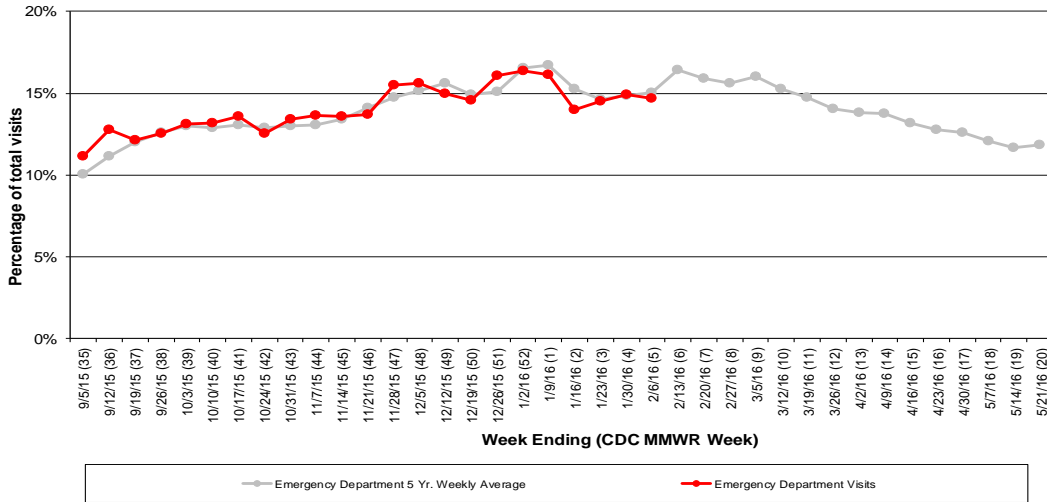


Figure 6: Selected Number of Over-the-Counter Medication Sales, 2015-16, Franklin County, OH

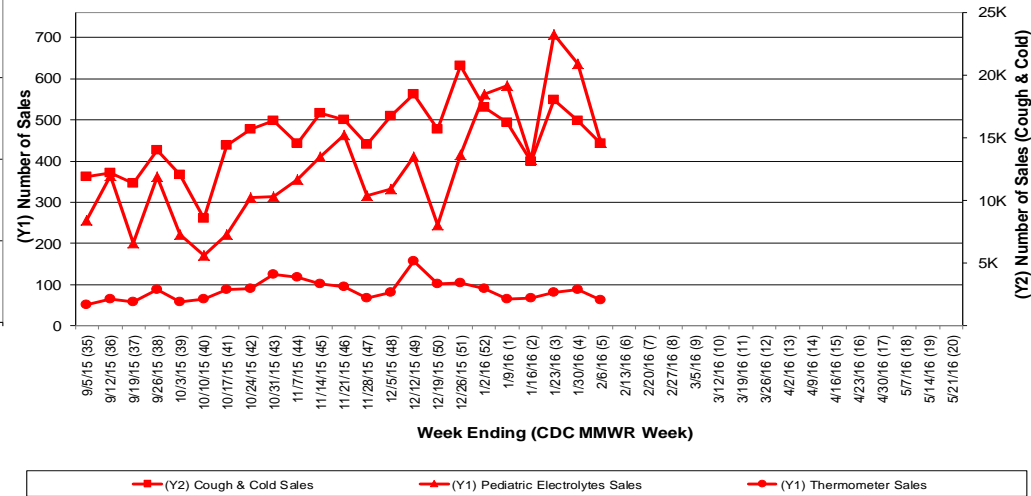
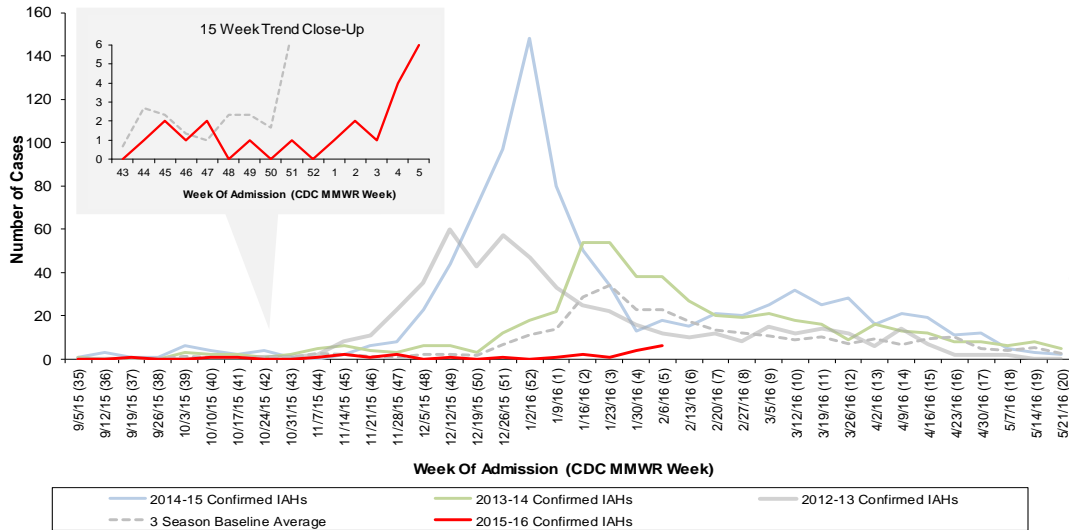


Figure 7: Franklin County Confirmed Influenza Associated Hospitalizations by Hospital Admission Week (As of 10:00 AM, 2/10/2016)
